



# Mosman Drill Hall Precinct – Consultation Summary

## 1) Draft Management Plan (Amendment 1)

## 2) Planning Application – Floodlighting of Outdoor Netball Courts

### Background

Over the period 12 September to 7 November 2019 the Harbour Trust publicly exhibited the following two planning matters relating to the Mosman Drill Hall Precinct:

- 1) Draft Management Plan for Mosman Drill Hall Precinct (Amendment 1); and
- 2) Planning Application — Floodlighting of Outdoor Netball Courts

The Harbour Trust's Management Plan that was current at the time for the Drill Hall Precinct, was adopted in 2006. Under the 2006 Plan, the use of the three existing outdoor courts was limited to daylight hours, and no lighting was to be provided.

The **draft plan amendment** included provisions that would permit lighting of the three existing outdoor sports courts and their use for sports training up to 8.30 pm. The draft plan amendment also provided updates to reflect matters such as current site conditions and other relevant statutory planning considerations.

The **Planning Application** submitted by Mosman Council proposed installation of twelve, 8-metre tall light poles on three existing netball courts at the Drill Hall precinct (i.e. four poles each court). The courts were proposed to be used for sports training until 8.30 pm for up to four evenings per week. The exhibited planning application is available at:

This summary provides an outline of issues raised in submissions and how these were addressed in the Harbour Trust's consideration of these matters.

### Public Exhibition

#### Notification

The Draft Management Plan and Planning Application were placed on public exhibition from 12 September – 7 November 2019 (eight weeks). Relevant documents were available for inspection on the Harbour Trust's website, in the Harbour Trust's office, Mosman Library and in the Customer Service Department of Mosman Council. The public was invited to comment on these two planning matters through a range of channels, including:

- Information was uploaded to the Harbour Trust website on 12 September 2019;
- Over 200 individuals and organisations including members of the Community Advisory Committee, government bodies and community groups were notified by email of the exhibition between 12 and 16 September 2019;
- Notices appeared in the *Mosman Daily* on Thursday 12 September (Early General News – page 16) and Thursday 10 October 2019 (Early General News – page 13);
- Approximately 600 homes and businesses in the vicinity of the Drill Hall Precinct were notified of the exhibition by letterbox drop (notices delivered on 12 and 13 September 2019);
- Information was included in the Harbour Trust e-newsletter on 2 October 2019; and
- Information was included in the Mosman Council e-newsletter on 21 October 2019 (news article included a link to the Harbour Trust website).

#### Drop-in Information Session

A drop-in session was held on-site at the Drill Hall, between 10am – 2pm on Saturday 12 October 2019. The session was promoted through the abovementioned channels. The session was attended by 19 persons. One person made a submission on the day; other attendees made submissions later in the exhibition period.

#### Community Advisory Committee (CAC)

Mosman Council's early proposal to install lights at the precinct's netball courts, and then the Draft Management Plan and Planning Application, were discussed at CAC meetings on 21 November 2017, 20 February 2018, 22 May 2018, 9 October 2018, 7 August 2019 and 6 November 2019. CAC members also made submissions during the public exhibition of the Draft Management Plan and Planning Application. Submissions are discussed further below.

#### Submissions Received

The Harbour Trust received 155 submissions from interested organisations and individuals (including CAC members) during the public exhibition of the Draft Management Plan and Planning Application.

The Mosman Netball Club also submitted a 430-person online petition in support of the draft Plan and Planning Application (it is noted that many petitioners had also separately made submissions). Petitions are treated differently from submissions, reflecting the fact that submissions represent an individual's considered response to an issue. This approach is common practice for Government authorities such as the NSW Government, North Sydney Council and the Department of the Environment.

All submissions and earlier correspondence, and advice from the CAC, was taken into account in the consideration of both the draft Management Plan, and the Planning application.

A summary of issues raised is discussed further below.

#### **Stakeholders – Board meeting**

Local residents from Cross Street, and representatives from the Headland Preservation Group, Mosman Council and Mosman Netball Club were given the opportunity to address the Board at its meeting on 5 December 2019, before considering the se two planning matters.

### Consideration of Draft Management Plan and Planning Application

At its meeting on 5 December 2019, the Harbour Trust Board considered submissions and issues raised by stakeholders and the CAC.

The Trust RESOLVED to:

- APPROVE an amendment to the Management Plan for the Mosman Drill Hall Precinct
- APPROVE a planning application by Mosman Council to install lighting on three existing outdoor netball courts
- AGREE to vary the precinct lease with Mosman Council to reflect these approvals
- AGREE to the proposed use of the lights until 8.30pm and AGREED to include additional requirements in the Management Plan to further ensure protection of local amenity, as follows:
  - Lighting usage to be limited to Monday to Thursday (except public holidays), and only during the period from 1 March to 15 September every year (dates inclusive);
  - Lighting is only to be manually activated (i.e. lights will not turn on automatically if not needed and will be automatically extinguished by 8.30pm); and
  - Mosman Council is to prepare an Operational Management Plan to coordinate management of the Drill Hall/Rawson Park area – to be periodically reviewed in consultation with relevant stakeholders.

These controls will be reflected in the approval conditions for the planning application. Mosman Council will also be required to undertake ongoing monitoring of lighting, traffic, parking and noise.

- NOTE the proposed lighting will be funded by a \$150,000 grant from NSW Government.

## Consultation Summary

### Key Issues Raised

Support for the installation of lights	Many submitters, including individuals (parents, players, coaches), and some local and state/national sporting groups, strongly supported the proposed installation of lights.	Support for the installation of lights by a large number of submitters, including local, state, national sporting groups is noted.
There are insufficient facilities for netball training in the Mosman local government area. Council has not fully investigated alternative locations.	<p>Submitters state there has been a large increase in membership of the Mosman Netball Club, and as a result there are insufficient facilities for netball training in Mosman. Installation of lights would assist to remedy this situation.</p> <p>Some submitters commented that illumination of these existing courts is a preferable solution to the undersupply of training facilities, to establishing new facilities in a greenfield location.</p> <p>Some submitters stated Mosman Council should provide facilities on Council land, rather than on Harbour Trust land.</p>	<p>Installation of lights will enable Mosman netball players to train for the required 90 minutes per week (up from 45 minutes per week). The Harbour Trust will encourage Council to proceed with these courts as soon as possible. Use of the lights should be maximised	Due to the cost of the lights and potential public benefits, one submitter recommended the courts should be used five nights per week, until 10 pm	Permitting use of the courts 8.30 pm beyond four nights per week, and outside the winter netball season, is not approved by the Harbour Trust. Limiting the courts’ use assists in managing impacts on the environment and local amenity, including noise, traffic impacts and lightspill.

The consultant found that the proposal is unlikely to have any significant impact on listed threatened species identified as potentially occurring at the site, or on any other native flora and fauna. This is due to the limited footprint of the lighting, the amount of time the lights are expected to be switched on, and the negligible potential impacts on native flora and fauna.</p> <p>Conditions of approval will require the implementation of mitigation measures to protect the amenity of the natural and built environment and local wildlife.</p> <p>All lights will be designed to have minimal light spill and will be directed towards the netball courts, not towards Sydney Harbour, residential properties, bushland or the Drill Hall. It was suggested temporary guide poles be installed to determine the visual impact. Further, the height of the poles will be limited to 8 metres, which is below the height of the canopy trees in the adjoining bushland to the south-east.
